**Rules and Regulations:** *This is a release of liability, and contract of responsibility. Please read before signing!*

- \$100 nonrefundable deposit required when making a reservation will be used to the total amount.
- No pets and a \$300 charge will be assessed if you have them in any lodging.
- Check in is at 1:00PM. Check out time is at 11:00AM.
- No refunds due to weather, change of plans, or early departure. All guests are financially responsible for the entire booking once your reservation has been made.
- A \$200 min cleaning fee will be charged if your lodging is dirty beyond normal use.
- All occupants must be registered and paid through the office. Facilities are for floaters and guests only.
- Falcon Floats reserves the right to refuse service to anyone.
- Quiet hours begin at midnight unless authorized by management to be later.
- There will be no refunds to anyone asked to leave by any Falcon Floats staff member.
- **Maintenance:** Please report any problems or damages in your bunkhouse the day of check-in to the manager. If not reported, we must assume the damage or loss occurred during your occupancy and we will have to charge you. When maintenance needs arise during your stay please contact the manager. It may be necessary for them to enter the bunkhouse during reasonable hours to perform minor repairs. There will be no refunds for the malfunction of any equipment including but not limited to air conditioning, appliances, or power outages.
- **Housekeeping:** Housekeeping is not provided during your stay but can be arranged ahead of time for a fee. Our housekeeper takes great care to provide you with a clean bunkhouse.
- **Maximum Occupancy:** The number of persons occupying your bunkhouse shall not exceed the number stated on your reservation if additional guests are added after your reservation is secured you must inform us upon arrival and charges will be added as necessary. If number exceed confirmed occupants listed it is a violation of rental agreement.
- **Visitors:** All visitors in your bunkhouse and campsite must stop at the office and sign in. They will be required to provide a valid driver's licenses and will receive a visitors tag to display in their windshield. All daytime visitors will be charged \$2 per person. Overnight visitors will be charged according to our extra person fee as stated in our rules. This policy is to protect our guests by controlling who is using our resort.

**Day visitors must leave the resort by 10:00PM.**

While we make every effort to have your bunkhouse ready, there may be a delay during peak season and your patience is appreciated. An additional night's stay will be charged for late check outs.

- Any property left during or after the trip is not the responsibility of Falcon Floats or its employees.
- Any damage/loss done to boats, equipment, or bunkhouse is the financial responsibility of all signed below.
- The property is privately owned. The renter accepts renting privileges with the understanding that he/she does hereby release Falcon Floats owners and its employees of all liability for loss or damage and injury, against claims resulting from loss or damage to property or injury to the person or any member of the family or guest of the registered renters arising out of the use of the resort facilities.
